LIMITED LIFETIME WARRANTY

CertaSpray® and CertaSpray® X Foam Insulation

What and Who Is Covered and for How Long

CertainTeed Corporation (CertainTeed), subject to the conditions and limitations listed herein, warrants to the original homeowner (purchaser) that its CertaSpray and CertaSpray X Foam Insulation, when such insulation is properly installed, will be free from manufacturing defects, including defects related to the material or to the design of the insulation, during the lifetime of the original purchaser so long as he/she retains ownership of the property in which the insulation was installed. This warranty covers individual residences only. This warranty is not applicable to insulation installed in a building that is not used as an individual residence at the time the insulation is installed.

CertainTeed will correct the defect or supply replacement insulation, at its election, free of charge, for any insulation which has been shown to have a manufacturing defect during the above-stated warranty period, up to a maximum liability equal to the cost of the insulation to replace the defective product. However, CertainTeed shall not be liable for any labor charges or for any other expenses whatsoever in connection with removal or installation of either the original or replacement insulation except to the extent CertainTeed, at its election, corrects rather than replaces the insulation determined to be defective.

Transferability

In the event the original homeowner (purchaser) sells the residence in which the insulation was installed, the coverage provided by this warranty will be transferred to the subsequent owner and will be limited in duration to 20 (twenty) years from the original date of the installation of the insulation. The subsequent property owner cannot transfer the warranty to another property owner.

How to Make a Claim

To obtain performance under this warranty, the original homeowner (purchaser), or the subsequent property owner, installation contractor or insulation supplier must promptly notify CertainTeed in writing of any defect following its discovery and must submit proof of date of purchase and installation as well as proof of property ownership. Notification must be sent to CertainTeed Corporation, P.O. Box 860, Valley Forge, PA 19482, Attention: IG Sales & Marketing. CertainTeed shall be permitted to inspect the claimed defect and if such examination discloses a defect covered by this warranty, shall, within a reasonable period of time after inspection, either correct or replace the defective insulation subject to the terms of this warranty.

Limitations

1. This warranty does not provide protection against, and CertainTeed will have no liability under this warranty for any failure, defect, or damage caused by situations beyond CertainTeed's control, including but not limited to:
 - A. Defects or failure caused by improper storage or by installation of the insulation not in strict adherence with the written instructions of CertainTeed.
 - B. Any damage to the insulation caused by impact of foreign objects, by lightning, gale, hurricane, tornado, earthquake or other acts of God, or by fire, explosion or other casualty.
 - C. Defects, failure or damage caused by materials adjacent to the insulation.
 - D. Damage caused by alteration after completion of the installation of the insulation, whether such alteration be by structural additions, changes, replacements or by equipment installation.
2. CertainTeed reserves the right to discontinue or modify any of its insulation products without notice, and shall not be liable to the original homeowner (purchaser) or subsequent property owner, installation contractor or supplier as a result of such discontinuance or modification.
3. If CertainTeed replaces any insulation under this warranty, it may substitute products designated by CertainTeed to be of comparable quality or price range in the event the product initially installed has been discontinued or modified.

Limited Warranty and Limitation of Remedies

THE OBLIGATIONS CONTAINED IN THIS LIMITED WARRANTY CONSTITUTE THE EXCLUSIVE REMEDY AND ARE EXPRESSLY IN LIEU OF ANY AND ALL OTHER OBLIGATIONS, GUARANTEES AND WARRANTIES, ORAL OR WRITTEN. APPLICABLE STATE LAW WILL DETERMINE THE PERIOD OF TIME FOLLOWING THE SALE THAT A HOMEOWNER (PURCHASER) MAY SEEK A REMEDY UNDER THE IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. CERTAINTEED'S OBLIGATIONS, RESPONSIBILITIES, AND/OR LIABILITY SHALL BE LIMITED TO REPLACING THE DEFECTIVE PRODUCT AND IN NO EVENT SHALL CERTAINTEED BE LIABLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, INCLUDING ANY DAMAGE TO THE BUILDING, ITS CONTENTS OR ANY PERSONS OR PROPERTY, THAT OCCUR AS A RESULT OF THE BREACH. NO FIELD REPRESENTATIVE OF CERTAINTEED, DISTRIBUTOR, DEALER OR INSTALLER IS AUTHORIZED TO MAKE ANY CHANGE OR MODIFICATION TO THIS LIMITED WARRANTY. IF YOUR STATE DOES ALLOW EXCLUSIONS OR LIMITATIONS OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.

This limited warranty gives you specific legal rights. You may also have other rights that vary from state to state.

This limited warranty is effective for CertainTeed CertaSpray and CertaSpray X Foam Insulation installed after April 1, 2008.
